- (0) indicates omission on account of page being torn or bound in such a way as to bind the writing, or omission for any reason other than indistinctness.
- (X) indicates the word or letter being indistinct which necessitated its omission.
- (?) indicates doubt whether the word or letter written just before it is correct.

All these characters are placed immediately after or slightly above the word or letter which they bear relation to. When the character (?) is written above the word, it is usually written a little to the right, as in the example given below:

In places where the word has the appearance of two spellings, the second spelling is placed in brackets immediately following the first spelling, or above it; also, where there is doubt that either transcription is correct, the character (?) is placed after or above the second.

There is just the same amount of writing on the typewritten pages of the 164 page book, East Hoosuck, Mass. Records Friends Meeting (Men's Minutes) as there was on hand written page in original book. This is not the case in the Minutes of the School Committee, as that book was so small as to size of pages, and having 41 pages, that it was thought best to use less pages in the typewritten copy.

The letters i and e are doubtful in some of the records, beginning about the year 1815, in the Men's Minutes, as the writing is so poor that it is difficult to decipher the spelling. The following words are doubtful as to spelling in the records from 1815 to 1819: friend(or freind); their (or thier); receive (or recieve). This occurs intermittently from about the year 1815 to 1819.

The word Junior is abbreviated throughout the book and the abbreviation is sometimes indistinct (especially in the 164 page book) and might be read in some places as Junr., Jurn., Jur. or Jun., as also in the abbreviation for Benjamin in some cases, it appears to be Benjn and in other places Benjr.

In the School records, in some words ending with the syllable ed, the d is written above the line (which could not be followed in the typewritten copy) and the letter e seems to be omitted at times and an apostrophe used instead.

There is sometimes an indistinct mark over figures which could be read either 00 or cts. Consequently, the character (?) is placed after these letters, when there was doubt.

The word, Mayfield, may be Myfield or vice versa.

Nothing has been omitted from the records -- mistakes in writing which afterwards were crossed out, are so shown.

The numbering of pages in upper right corner is copied from the numbering in book and as the pages were bound, but there was pencil memoranda in the middle of the top of most pages, sometimes in brackets, which I have copied, which, if followed, will make the context read correctly, or the following table may be followed. The abbreviation r.c. means right corner numbering.

Beginning with page 33 (R.C.) the dates appear to be consecutive up to and including page 162 (R.C). From page 162 (R.C.) to page 11 (R.C.) context reads correctly, also dates are consecutive. This would leave page 163 (R.C.) to be read after page 24 (R.C) but, although the dates of meeting appear to be consecutive, there is a decided change of handwriting on page 163 (R.C.) which would seem to indicate that there might be a page or pages missing, as page 163 (R.C.) does not commence the record of a meeting.

The School Committee Records begin a new numbering and have an index sheet, so there can be no confusion between the records of the East Hoosuck, Mass. Records, Friends Meeting, (Men's Minutes) and the School Committee Records, There are 164 pages in the East Hoosuck, Mass. Records, Friends Meeting, and 33 pages in the School Committee Records.
